

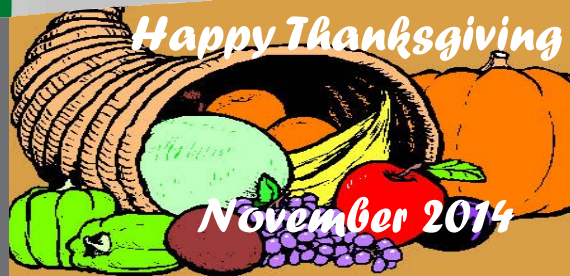

## Columbus Day – Italian Heritage Day, Indigenous Peoples Day?

Many of you expressed concern that the Mayor & City Council chose to move forward with the creation of a holiday celebrating Indigenous Peoples on the same day as the day known nationally as a federal holiday: Columbus Day. Your concerns have not gone unheard.

In early September multiple people from various parts of the Greater Seattle Italian-American community began their own efforts to express our dismay & disappointment with the process the members of City Hall took to create the holiday & their failure to include the local Italian-American community in the process. As it has happened before in our community, the communication of the various efforts was limited and as fractured as our community. This led to some emotional expressions & ultimately a rude awakening: as a culture we are two things: fractured, and assimilated into the American mainstream. The members of City Hall did not think twice we were a community that may take offense to their actions, let alone have strong passions about Columbus Day. As the city moved forward with their resolution a number of people began to act together to bring unity, coherence, & clarity the voice of our community.

Those people have formed a group named: Italian American Heritage

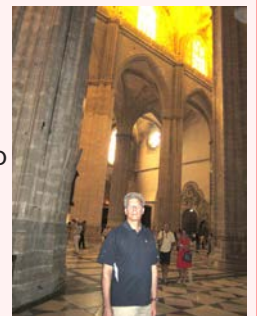

My apologies for omissions in the last newsletter. The Club had a number of other members who Chaired or Co-Chaired other activities at Festa 2014.

For quite a number of years club members Ray & Caroline Petre have been the Chairpersons in charge of the Historical Photo Display at Festa. For those of you who have not seen the photo display, it really is quite something. It's not uncommon to see someone brought to tears by the display, or to find a photo of someone from their family that they were not aware of. The display renews the sense of involvement & commitment local Italian-Americans had previously & have now for Seattle.

The Art show at Festa has gone so well they have received requests to produce similar shows at other events. Alliance. The IAHA is formed of various business, legal, & civic leaders in the greater Seattle area who are uniting to address the issues City Hall has created in their resolution. We have local & regional representation from the Order of the Sons of Italy (OSIA), Italian Chamber of Commerce for the Pacific North West (ICCPNW), National Italian American Foundation (NIAF), Italian Club of Seattle (ICoS), the Italian Community Hall (CASA), the Dante Alighieri Society (Dante), West Side Italian Civic Club (WSICC), & concerned individuals. The group is still growing and taking steps to guarantee the various parts of our community are represented, or at the very least are given a chance to participate, no Italian-Americans left behind so to speak. One of the keystones of this group is to ensure that we are sending a unified message to the public, the press, & the politicians in matters regarding the community, its relations with City Hall, & the celebration of our heritage. The IAHA is dedicated to inclusion & communication in our community.

Early on, in a more loosely organized fashion, before the 2014 Columbus Day holiday, members of the group were responsible for multiple communications with the Mayor & City Council of Seattle, including separate in office meetings with Councilman Licata & the Mayor, public testimony at council meetings, creating a Facebook page, reaching out to national representatives, fundraising, a press conference, & a full page ad in the Seattle times.

The group's next steps include a survey of voters registered in the City of Seattle, fundraising, & investigation into the alternatives before us in the public & political

arenas.

As the group continues to move forward, we will make sure to communicate with & include the community at large in our efforts & strategies, while continuing to seek input from the community in terms of what are our priorities & where our opportunities lie.

The way the City of Seattle treated (or did not treat at all) the Italian-Americans in Seattle during this process should serve as a slap in our collective faces all across our fragmented community. If we want to be recognized, we need to unite & speak as one. The IAHA is dedicated to make that happen.

## 2014 Gil Centioli Memorial Award Winner Joe Fugere – Founder, Tutta Bella Neapolitan Pizzeria

Joe was raised in Seattle's Beacon Hill neighborhood completely immersed in the local Italian community. After a career at Starbucks, he followed his roots "home" to Naples where he was inspired to bring the artistry of wood-fired pizza back to Seattle. In 2004, Joe opened his first restaurant in Columbia City and currently has five neighborhood locations in the greater Seattle area that have all received certification by the Associazione Verace Pizza Napoletana (VPN).

Tutta Bella strives not only to be the most respected Neapolitan pizzeria in the world, but also a meaningful business that nourishes lives. Tutta Bella's neighborhood restaurants actively get involved and give back to their local communities. With Joe's direction, Tutta Bella regularly leads socially-responsible, small business initiatives in environments ranging from the White House to local neighborhood councils.

- Joe attended the signing of the 2010 Small Business Lending Act at the White House where President Obama recognized Tutta Bella for its contribution to economic recovery. Two years later, upon a presidential request, Tutta Bella made a special delivery to Air Force One.


